This book examines the cultural work of space and memory in Canada and Canadian literature, and encourages readers to investigate Canada within its regional, national, and global contexts. It features seven chapters in English and five in French, with a bilingual introduction. The contributors invite us to recognize local intersections that are so easily overlooked, yet are so important. They reveal the unities and fractures in national

understanding, telling stories of otherness and marginality and of dislocation and un-belonging. Ce livre examine l'importance culturelle de l'espace et de la mémoire en contexte canadien et plus spécifiquement dans les littératures du pays, afin d'inviter des lectures neuves des questions régionales, nationales et globales. This collection of essays analyzes the relationships that exist between esotericism and music from Antiquity to the 20th century, investigating ways in which magic, astrology, alchemy, divination, and cabbala interact with music. The volume seeks to dissolve artificial barriers between the history of art, music, science, and intellectual history by establishing an interdisciplinary dialogue about music as viewed against a specific cultural background. The synthesis of scientific and historical contexts with respect to music, explored here on a large scale for the first time, opens up a wealth of new approaches to music historical research, music performance, and musical composition. Each chapter presents either a unique example of music functioning within esoteric and scientific traditions or a demonstration of the influence of those traditions upon selected musical works. Between Folk and Liturgy, the title of this collection, should not be understood to refer to some fixed point, some stable place between the two extremes of an illiterate and a literate culture. Rather, the title flags the wide and colourful spectrum of medieval dramatic possibility. Perhaps except one, none of the ten essays published here deal with a drama existing purely at either end of this scale. They add to our impression of the teaming fecundity and hybridism of early European drama, an impression that grows apace once we start to consider dramas situated Between Folk and Liturgy. The geographical terrain that the essays traverse ranges from the British Isles in the west to Poland in the east. The suppleness of the approaches taken here is the minimum critical requirement of anyone wanting to do justice to so complex and multifold a phenomenon as is early European drama.

French Riviera is one of the first modern resort areas. It began as a winter health resort at the end of the 18th century. With the arrival of the railway it became the playground and vacation spot of British, Russian, and other aristocrats, such as Queen Victoria and King Edward VII, when he was Prince of Wales. In the summer, it also played home to many members of the Rothschild family. In the first half of the 20th century, it was frequented by artists and writers, including Pablo Picasso, Henri Matisse, Edith Wharton, Somerset Maugham, and Aldous Huxley, as well as wealthy Americans and Europeans. After World War II, it became a popular tourist destination and convention site. Many celebrities, such as Elton John and Brigitte Bardot, have homes in

the region. The French Riviera is a major yachting and cruising area with several marinas along its coast. According to the Côte d'Azur Economic Development Agency, each year the Riviera hosts 50% of the world's superyacht fleet, with 90% of all superyachts visiting the region's coast at least once in their lifetime. As a tourist centre it benefits from 300 days of sunshine per year, 115 kilometres (71 mi) of coastline and beaches, 18 golf courses, 14 ski resorts and 3,000 restaurants. Although the Riviera is famous for the glamour of St. Tropez, Monaco or the Cannes Film Festival, there are many other less well known attractions, such as the perched villages of Eze and Gourdon, the perfumeries of Grasse and the glass blowers of Biot, the potters in Vallauris. The Riviera has been the inspiration for many well-known artists such as Picasso and many of their works are on display in local museums and art galleries. That the poet John Gower was a major literary figure in England at the close of the fourteenth century is no longer in question. Scholarly attention paid to him and to his work over the past twenty- five years has redeemed him from an undeserved obscurity imposed by the preceding two hundred. The facts of his life and career are now documented, and recent critical assessment has placed his achievement most accurately alongside Chaucer's, Langland's, and the Gawain- poet's. Unique among his contemporaries, all of whom undoubtedly read and used French in some measure, Gower alone has left us a

significant body of verse and prose in Anglo-Norman; chiefly, the twelve-stanza poem *Mirour de l'Omme*, the *Cinkante Balades*, and the *Traitié pour les amantz marietz*. We are offered in this concordance of his Anglo-Norman work a unique opportunity to view a poetic language as it was written and read in England until Gower's death in 1408 and beyond.
